




# Halogen Testing (oxygen bomb) Flow Chart


# **Phthalates Testing Flow Chart**


# **HBCDD Testing Flow Chart**


# PFOS/PFOA Testing Flow Chart


# **PAHs Testing Flow Chart**


# TBBP-A Testing Flow Chart
